You agree that C2C has no responsibility to insure against damages or harm, and that, if you desire insurance, you shall obtain it at your own expense. You agree to defend, indemnify and hold harmless C2C, the event facility, and their respective officers, employees, and/or agents against any loss, damage or expense (including attorney's fees) arising from, relating to, or otherwise concerning this agreement, unless proximately caused by the indemnified party's willful mis-conduct or gross negligence.
